

# **ENERGY ALIVE® ETHICS AGREEMENT / STATEMENT OF INTENT**

(Must be signed by all Energy ALIVE® practitioner candidates)

Traditionally, a code of ethics was an unwritten understanding within an individual or group that defined their principles and standards of behavior. In modern times, many organizations are finding it useful to create a written code of ethics to encourage a specific point of view in their constituents, and to outline in very broad strokes the actions and behaviors most supportive of their work.

Since Energy ALIVE is an energy healing modality that includes practitioners, students, instructors, and clients, our code of ethics encompasses all groups equally. Our most basic ethic is to support well-being in ourselves, our clients, our instructors, our professional colleagues, and the world around us. However, we cannot take care of others without first tending to ourselves.

#### A. SELF

- 1. Healing begins at home. This means that we agree to foster a daily, conscious practice of awareness of our own physical body, our mind and its beliefs, our emotions, and our spiritual (higher resonant) selves.
- 2. We strive to find balance in all the sectors of our life: home, work, family, etc., and between activity and rest, so that we can be more present and engaged in all areas.
- 3. We agree to use the techniques and practices of Energy ALIVE on ourselves throughout our week, and to incorporate them into our daily routine.

### B. ENERGY ALIVE®

- 1. We understand and acknowledge that Energy ALIVE® is an energy healing modality that draws upon the innate healing response within each participant, and that it is the client/recipient who is creating their own healing, not the practitioner (unless, of course, the practitioner is working on herself/himself).
- 2. We understand and agree that only certified Energy ALIVE® practitioners or instructors can use the name Energy ALIVE on their business cards, advertisements, brochures, or other business or marketing materials. Anyone else who wishes to use the Energy ALIVE® name must seek written permission in advance from the founder of Energy ALIVE®, Henri Rand Furgiuele.
- 3. We understand and agree that it is the responsibility of the individual Energy ALIVE practitioner and instructor to become informed of any laws (local, city or national) that might govern their professional practice, and to comply fully with such regulations, wherever they may live.

#### C. PROFESSIONAL CONDUCT

- 1. When we practice Energy Alive®, we agree to offer the highest quality services possible for the wellbeing and satisfaction of each client. We understand each client is to be treated with respect and sensitivity at all times and that a professional demeanor must be maintained throughout all healing sessions and all healing-related events.
- 2. We agree that when we practive Energy Alive®, the client always has full perogative with regard to their health care options. We do not diagnose a client's physical, psychological or spiritual condition. We do not prescribe substances and/or remedies of any kind, or otherwise interfere with a client's medical treatment plan or influence their relationship with medical doctors or other health care professionals.
- 3. We understand and agree that Energy Alive® can be done with or without physical contact and that, if physical contact occurs, it is always in accordance with generally accepted standards of professional conduct. The touch should be light, gentle and always administered through any clothing being worn at the time.
- 4. When practicing Energy Alive® we understand that any sexual-oriented advances or sexual-oriented connection with clients is NEVER appropriate, even with client consent. Sexual harrassment is NEVER allowed. There is no place in an Energy Alive® healing session for this kind of conduct. We agree that all clients have the right to a safe and respectful environment in which to experience the healing process and can always expect and receive that with Energy Alive practitioners. Inappropriate sexual behavior includes all forms of overt and covert communication of a sexual or seductive nature, including but not limited to, speech, gestures and physical contact.

#### D. CLIENTS

- 1. We understand and agree to keep private and confidential the content of a client's healing session, and any personal information revealed.
- 2. We understand and agree to store all client contact information, data about their payment history or financial accounts, and session records in a safe place where their privacy can be assured.
- 3. If client documentation and files are kept on a shared or personal computer, we agree to keep these client files separate and distinct from all other files, and to password protect them so that other users of the computer cannot access client information.
- 4. We agree to reserve Energy ALIVE client lists for energy healing and Energy ALIVE purposes.

#### E. PROFESSIONAL FINANCES

- 2. As practitioners of Energy ALIVE, we understand and agree to discuss our fees openly with clients and prospective clients, and to answer questions realistically as to the nature and scope of this technique.
- 3. When we practice Energy ALIVE, we acknowledge that although we have complete freedom in how much we charge for healing sessions, it is always a good idea to be mindful of the economic needs of the client. Our fees should also reflect our own experience level and growth as an Energy ALIVE practitioner.
- 4. We understand and agree that any taxes due from income received as an Energy ALIVE practitioner or instructor are our own personal responsibility.

#### F. COLLEAGUES

- 1. We acknowledge that Energy ALIVE® exists in a world of other alternative healing techniques, and that developing collegial relationships with other health care professionals can be very beneficial.
- 2. We agree that it is beneficial to Energy ALIVE® practitioners to continue advancing in the world of energy healing, and to stay current with new trends in this field. This benefits our clients and prevents a sense of isolation or insularity from developing.
